Blueprint's new program options have been developed to meet new requirements implemented by Workplace Health and Safety Queensland (WHSQ) that came into effect from 1st July 2008. These include changes to recording formal and practical training and the process for license lodgment.

Training must be held on site and minimum numbers apply.

RPL (recognition of prior learning) may be available to those trainees who can demonstrate prior experience; knowledge and/or training. RPL applicants must also undertake a formal 'challenge test' (licensing assessment).

Blueprint Employment & Training Inc (Blueprint Inc) offers this new Order Picking forklift program (*as per new changes to the Workplace Health & Safety Regulations 2008*) with minimum numbers on your site.

This **Blueprint Formal Delivery Program** is targeted towards those students who have no or little prior experience or training in order picking forklift operations and whose employer wishes only to provide the log book practical experience.

The program includes self-paced study (approximately 12 hours); and 2 days face-to-face training. Upon completion trainees will be issued with an individualized Informal Learning Record (Log Book) and will be required to undertake approx 40 (nominal) hours operational experience under supervision. Once this experience has been gathered trainees will sit a 'challenge test' (licensing assessment). Note trainees must be 18 years or over to undertake a licensing assessment.

The total cost of the program is of \$550.00¹ per person.

1) Enrolment and Course commencement

- a) \$550.00 at time of enrolment (non-refundable)
- b) All training materials provided
 - i) Order Picking Forklift Workplace Health & Safety Manual
 - ii) Order Picking Forklift Operations Theory Manual
 - iii) Individualised Informal Learning Record (Log Book)
 - iv) Assistance in the development of a Training Plan to meet new WHSQ requirements

2) Formal Training - 2 days "Face-To-Face" practical and theory training

- a) Conducted onsite at employers venue
- b) Training is usually conducted in small groups

3) Operating Experience²

- a) Trainees are required to gain operating experience of a nominal 40 hours between training and undertaking the licensing assessment.

4) Assessment and Licensing

- a) Blueprint require that the assessment must be undertaken within 90 days of the above training being completed³
- b) Assessment undertaken on site at employer's premises
- c) Students **MUST** be 18 years of age or over
- d) The Challenge Assessment includes a written assessment (short answer questions) and a practical assessment component.
- e) After successful completion of the assessment applicants will be issued with:
 - i) An application form and information on license lodgment
 - ii) Copy of the assessment summary
 - iii) Statement of Attainment
